Draft Environmental Impact Statement of Coral Reef Ecosystem Fishery Management Plan Available for Public Review

The draft environmental impact statement (DEIS) and draft fishery management plan (FMP) for coral reef ecosystems of the Western Pacific Region and associated documents (totaling more than 1,100 pages) are available for public review and comment. The FMP proposes to establish marine protected areas, fishing permit and reporting requirements, allowable harvesting gears and methods and a framework process for future regulatory adjustments. Volume I contains the FMP (including draft regulations and gear catalog) and the draft Regulatory Impact Review/Initial Regulatory Flexibility Analysis. Volume II is the DEIS. Volume III is the essential fish habitat descriptions for management unit species.
