Endangered Species Act

 1970: Humpback whales listed as endangered under the Endangered Species Conservation Act of 1969

1973: Endangered Species Act enacted, automatically incorporated humpback whales onto the list as

endangered

1991: Recovery Plan completed

Currently: listed as endangered as one global species





ESA Status Review

- 2009: NOAA Fisheries "self-initiated" status review not petition driven
- Because of current global listing, status review coordinated by NOAA Fisheris Office of Protected Resources
- Federal Register Notice solicited new information from public regarding status of humpback whales
- 2011: "Global Review of Humpback Whales" Technical Memorandum (NOAA-TM-NMFS-SWFSC-474)



ESA Status Review

- 10 member Biological Review Team ("BRT")
 - √ 9 Federal Scientists
 - ✓ 1 Scientist from Oregon State University
- Draft BRT Report recently completed and is currently undergoing peer review
- BRT will address peer review comments, and finalize their report



Next Steps

- NOAA Fisheries will consider BRT recommendations and, if appropriate, delineate Distinct Population Segments
- Consider the listing status of each "DPS"
 - Endangered
 - > Threatened
 - Not Warranted
- Publish proposed rule, seek public comment
- · Once public comments are addressed, publish final rule



Future Considerations

- NOAA Fisheries will then consider the following for any humpback whale <u>listed</u> DPSs:
 - Section 4(d) rules for any threatened DPS
 - Critical Habitat
 - Recovery Plans
- Section 4(g) requires species recovered & removed from Endangered Species List be monitored in cooperation with the States(s) for a period of not less than 5 years.
 - Purpose: to detect any failure of a recovered species to sustain itself without the protection of the ESA

Authorization of "Take" for Hawaii-based Longline Fisheries

Shallow-set Fishery

 2012 Biological Opinion's Incidental Take Statement authorizes 2 humpback whale interactions annually

Deep-set Fishery

 2005 Biological Opinion's Incidental Take Statement (amended 2010) authorizes 4 humpback whale interactions over a 3-year period





Marine Mammal Protection Act

- 1973: Humpbacks designated "depleted" throughout range
- Automatic depleted designation for species listed as endangered or threatened under the ESA
- MMPA manages by "stock":

a group of marine mammals of the same species or smaller taxa in a common spatial arrangement, that interbreed when mature

 Central North Pacific stock migrates between Alaska and Hawaii (PBR for this stock = 61.2 animals)
