MSA Reauthorization Timeline

- **May 7-9, 2013:** Managing Our Nation's Fisheries 3 – findings and recommendations developed for Congressional consideration.
- **March 2013 – Present:** Reauthorization hearings before the 113th Congress
- **November 8, 2013:** CCC letter to Hastings & Begich
- **December 19, 2013:** House Natural Resource Committee releases a discussion draft for public comment.
- **End of 2014:** House Natural Resource Committee's expects to move forward on reauthorization legislation.

CCC Priorities for Improvement

 - Providing flexibility in rebuilding schedules
 - Addressing discontinuity of the 10-yr requirement
 - Taking socioeconomic factors into account
- Ending overfishing
- Mixed stock fishery flexibility
- Recreational fishery considerations
- Management of data-poor stocks
- International fishery management issues
