2017 SBRM Requirements

2017 SBRM rule requires every Fishery Ecosystem Plan to:

- ➤ Identify the required procedure or procedures that constitute the SBRM for each fishery
- Explain in an FEP how the SBRM meets the purpose described in the rule

Councils must conduct a **fishery-specific analysis** when establishing or reviewing an SBRM that addresses:

- 1. The **characteristics of the bycatch** occurring in the fishery when available;
- 2. The **feasibility of the methodology** from cost, technical and operational perspectives;
- 3. The **uncertainty of the data** resulting from the methodology; and
- 4. How data resulting from the methodology are used to assess bycatch in the fishery.
- → Consistency required by February 21, 2022

Status of SBRM Review

- > Council/PIRO SFD staff conducting SBRM Review
- Plan Team reviewed bycatch data in SAFE report, identified areas that need improvement
- Existing FEP identifies primary data collection methodologies (creel, logbook, observer) as SBRM
- > SBRMs in the FEPs may need to be updated to:
 - Remove SBRM for fisheries targeting Ecosystem Component Fisheries
 - Include explanations on how SBRM meets purpose
- Pending further guidance from SFD/GC
- Full review document at September meeting
