Protected Species Conservation

Through an amendment to the Bottomfish and Seamount Groundfish Fishery Management Plan established under the Magnuson-Stevens Fishery Conservation and Management Act, mandatory observers are required aboard the Hawaii-based bottomfish vessels in the Northwestern Hawaiian Islands (NWHI).

The program is responsible for fielding observers to obtain data on incidental protected species take and collect fishing effort data. The observers document interactions of all protected species, tallies by species of the fishes that are kept and discarded and processes selected specimens for life history information.

The Pacific Islands Region in Hawaii receives observer data to calculate official estimates and produce technical reports. The Pacific Islands Fisheries Science Center receives biological samples for analysis.

The Hawaii-based bottomfish fishery has been monitored under a mandatory observer program since October 2003. Beginning October 2003, branch personnel have conducted daily shoreside dock rounds in Honolulu to determine which fishing vessels are in port. These dock rounds are used to obtain an estimate of fishing effort on a real-time basis by assuming that a vessel is fishing when it is absent from the harbor. This report is used to ensure prompt dissemination of Hawaii Bottomfish Observer Data and may be revised after final data editing has been completed. The following table summarizes percent observer coverage for vessel departures, vessels arriving with observers, and protected species interactions for vessels arriving with observers during 2005.
