Dear Mr. Ebisui:

I am pleased to report to you and the rest of the Council the following summary of U.S. Coast Guard fisheries law enforcement activities in the Western and Central Pacific Region for the period of March 1, 2015 to May 31, 2015.

From February 21<sup>st</sup> to March 17<sup>th</sup> CGC SHERMAN deployed on a multi-mission patrol. During this deployment CGC SHERMAN patrolled the U.S. EEZs of the Main Hawaiian Islands and Kingman Reef/Palmyra Atoll and the foreign EEZ of Cook Islands. CGC SHERMAN completed eight boardings, assisting the embarked Cook Islands shiprider with boarding three U.S. flagged purse seine vessels located inside the Cook Islands EEZ under the Cook Islands/U.S. shiprider agreement. No violations of Cook Islands or U.S. law were observed. CGC SHERMAN completed four boardings under the authority of the Western and Central Pacific Fisheries Commission (WCPFC) High Seas Boarding and Inspection scheme with no violations observed. Enforcement actions on the high seas have a derivative deterrent effect in the U.S. EEZ and help compel foreign fishers to respect U.S. EEZ boundaries. CGC SHERMAN also completed one domestic boarding of the Honolulu based longline fleet with no violations observed.

From March 2<sup>nd</sup> to 8<sup>th</sup> CGC GALVESTON ISLAND patrolled the U.S. EEZ of the Main Hawaiian Islands, no foreign vessel incursions were detected. CGC GALVESTON ISLAND completed ten boardings on the Honolulu based longline fleet, noting safety violations on four of the vessels and citing two vessels for lack of a U.S. Coast Guard approved boarding ladder.

From March 15<sup>th</sup> to 22<sup>nd</sup> CGC KISKA patrolled the U.S. EEZ of the Main Hawaiian Islands, no foreign vessel incursions were detected.

From March 15<sup>th</sup> to 24<sup>th</sup> CGC SEQUOIA patrolled the U.S. EEZ of Guam and the Northern Mariana Islands, no foreign vessel incursions were detected.

From March 23<sup>rd</sup> to May 4<sup>th</sup> CGC KUKUI deployed on a multi-mission patrol. During this deployment CGC KUKUI patrolled the U.S. EEZs of the Main Hawaiian Islands, American Samoa, and Kingman Reef/Palmyra Atoll and the foreign EEZ of Kiribati (Line Islands). CGC KUKUI completed eight boardings, assisting the embarked Kiribati shiprider with boardings of three foreign flagged longline vessels registered to fish in the Kiribati EEZ, one violation was noted for an excessive amount of shark fins. Five boardings were conducted on the American Samoa based longline fleet. Multiple safety violations were noted on three of these vessels, one of which had its voyage terminated due to an especially hazardous condition.

From April 13<sup>th</sup> to 17<sup>th</sup> CGC GALVESTON ISLAND patrolled the U.S. EEZ of the Main Hawaiian Islands, no foreign vessel incursions were detected. CGC GALVESTON ISLAND conducted eight boardings on the Honolulu based longline fleet, noting safety violations on five of the vessels and citing one vessel for lack of a U.S. Coast Guard approved boarding ladder.

On April 16<sup>th</sup> and 23<sup>rd</sup> CGC WASHINGTON patrolled the U.S. EEZ of Guam. No foreign vessel incursions were detected.

From 26<sup>th</sup> April to May 1<sup>st</sup> CGC MELLON patrolled the U.S. EEZ of the Main Hawaiian and Northwest Hawaiian Islands. Their embarked aircraft flew patrols of the Northwest Hawaiian Islands. No foreign vessel incursions were detected.

From April 27<sup>th</sup> to 30<sup>th</sup> CGC ASSATEAGUE patrolled the EEZ of Guam and the Northern Mariana Islands. No foreign vessel incursions were detected.

Between March and June, District Fourteen C-130 aircraft flew multiple patrols of the U.S. EEZ of the Main Hawaiian Islands and American Samoa, one patrol of the Northwest Hawaiian Islands, and one patrol of Kingman Reef/Palmyra Atoll. No foreign vessel incursions were detected.

The District 14 enforcement staff participated in several fisheries enforcement-related meetings during this reporting period. These meetings included an introduction to the new WCPFC Executive Director and Compliance Manager, meeting with the Hawaiian Islands Humpback Whale National Marine Sanctuary staff to discuss proposed regulations, the NOAA National Observer program report meeting, the Annual False Killer Whale Take Reduction Team meeting, and the Northwest Hawaiian Islands Coral Reef Ecosystem Reserve Advisory Council meeting.

Sector Honolulu established a new process to follow up commercial fishing vessel safety examinations identifying machinery, electrical, or structural deficiencies with further assessment by Marine Inspectors. Since implementing this policy, there has been an approximate 65% reduction in reportable marine casualties from these vessels. Some examples of reportable casualties include loss of steering, loss of main engine propulsion, and loss of generator power.
